#### **PAST EVENTS:**

**November 11 – Cimarron Mesa – Frank Whiston:** Jeff Boggs lead this trail ride; Frank spoke about it in Jeff's absence. The group went out and explored around. Any trails that they found would take a lot of work before they could make it up, so they didn't run any. Roads are still very bad to get out there.

**Food Drive – Frank Whiston:** About a dozen vehicles turned out for this event, which was a really good showing. We have not yet received a letter from Roadrunner Food Bank, which normally gives the number of pounds donated.

**December 1**<sup>st</sup> – **Green Canyon/Cabin Loop Exploratory (T or C Area)** – **Jack Dickey:** Bob and Sandy Powell met them at Williamsburg along with Curtis Hill. ## Director of Environmental Affairs By Frank Whiston

There are 155 National Forests in the US. Most have had to do some form of Travel Management decision to comply with the Travel Management Rule. Of all those decisions, there have been only THREE challenged in court to date by the OHV community (the NMOHVA lawsuit is #3). This is about much more than the camping, roads and trails lost in the Santa Fe National Forest. It is about sending a clear message to the agency that we are smarter, stronger, and much more determined than we were in the past. Help NMOHVA send that message! Money is what will make this thing go. Legal challenges are expensive and will require the greatest extent of financial support possible from its membership. So, what does that mean to us? I challenge each NM4W member (who is also a member of NMOHVA via the Club's membership) to donate two tanks of gas to the NMOHVA Access Defense Fund. Several members have already made equivalent donations and I applaud each and every one of you. What would you give to get routes back that NM4W has enjoyed for many, many years such as Caja Del Rio aka "The Blowhole", Tank Trap, Paliza Canyon, and the Guadalupe crossing to name a few? How about a couple tanks of gas? The national average price at the pump is \$3.27/Gal right now. Two 18 gallon tanks would be ~\$120. If all 63 NM4W member families donated \$120, NMOHVA would receive \$7,560. That is the kind of support that NMOHVA is going to need. Together, we can do more!

## LEAD A TRAIL By Mark Wolf

Hey! We need trip leaders to the following:

Canyon de Chelly, Hole in the Rock, The Maze, Alamogordo, Caballo Mountain/Palomas Gap, Gallup, Salida, Colorado, Silverton, Colorado, Arizona runs (per Charles Wells), California, Nevada, and wherever else it would be cool to go, which covers a lot of ground!

If you don't know these places, it's high time to find out what they offer! Ask me or anyone who has been there. We'll get you started towards leading the trail. We don't want to go to meetings all the time! Lead a trip and get those points racked up! You could win a cool gift certificate and have fun doing it!

Here are a few tips for Trail Leaders!

### Safety Rules for the Four Wheel Drive enthusiast

#### 1. Know your vehicle!

This is probably the most important thing for your four wheeling pleasure. Knowing the limits, low points, and strong/weak points are really important. Every vehicle is vulnerable, but not in the same place. Knowing what to protect is really important in preserving your fun.

### 2. Always wear your seatbelt and ensure others in your vehicle do the same!

This almost goes without saying. However, people tend to think that because they're going slow they're out of danger. Expect the unexpected! You never know when a dirt bank will give way or a tire will go flat on a side hill causing your vehicle to tip. Staying in the vehicle is the safest thing to do. Staying in your seat is the best way to "ride it out".

### 3. Never go alone!

This is probably one of the worst sins that a Four Wheel Drive enthusiast commits. You can be the most prepared person/vehicle on the trail, but can still get stranded when something unexpected happens. Having at least one other vehicle around gives you peace of mind and it's a whole lot more fun to go with someone else.

### 4. Plan ahead for short or long trips.

Always take plenty of water for you, your passengers and your vehicle. Pack enough food to sustain you for more than the expected length of the trip. Weird things can happen and you can become stranded. Being prepared is one way to survive the ordeal. Make sure you have plenty of warm clothes in the vehicle. Some matches are also a good idea. Think about the trip you're going to take and pack accordingly. Always perform a "readiness review" of the vehicle.

## 5. Tell someone where you're going, how long you expect to be gone and approximately when you'll get back and let them know when you return.

This can save your life! If you don't return your friends/family will take the necessary steps towards rescue. Whether that is simply to go look for you or calling 911 will be their choice. At least there's someone who can do that for you! You may take a cell phone and think you're covered, but in this state and many others there is no service in the back country and the phone is useless.

### 6. Tie anything and everything down in the vehicle!

Anything that can move around becomes a potential "missile". You never know when your vehicle will tip causing any loose items to become projectiles. Besides, things sliding around can cause undue ruptures or breakage. You wouldn't want your spare gasoline or water to become lost due to a rupture from sliding around. That would leave you unprepared and open to a disaster. Coolers can damage the human body easily should they become projectiles.

### 7. If your view is blocked ahead/behind, get out and walk first!

Just because the trail goes to the top of the hill, doesn't mean the trail keeps going. There could be a 150' drop off on the other side of the hill! Also, water can look shallow in certain light. Check it with a stick to verify the depth. Watch out for holes. Getting out to walk around and check things out will save you embarrassing and maybe tragic moments.

### 8. Trust your gut feeling – Don't take chances!

If it feels wrong, it probably is. There's no need in pushing you or your vehicle beyond their respective limits. It will always end up in a bad situation. Most stranded people are the victims of their own mistakes. Like that saying for kids and drugs - Know when to say no! You have nothing to prove.

### 9. Ensure your spare tire, tire tools, and jack are in good working order at all times.

These are critical items to check in your "readiness" review. You never know when a perfectly good tire will deflate due to a manufacturer's defect. Keep your spare in good working order as needing it is unpredictable. Your tire tools are also important and that includes your jack. You can't change a tire very easily without all of these items. A hi-lift jack is recommended as it is a versatile, multi-functional tool. Flat tires are a common occurrence. Be prepared.

## 10. Always carry a fire extinguisher, first aid kit, shovel, flashlight and water. A basic tool kit is also recommended.

Most of the time these things come in handy when you meet less prepared folks on the trail. Those who don't know these 10 basic safety steps will venture off and eventually get into trouble because they failed to prepare. However, in the unlikely event you do get into trouble, it will be a big relief to know that you prepared yourself for trouble.

**Remember this!** Most of all stay with your vehicle! They are a lot easier to find than people. If you have followed the steps above, someone will come looking for you when you don't return as expected.



## Caja del Rio – Blow Hole Run II By Mark Wolf

On Saturday, December 15, 2012 seven vehicles joined me for a run to see the "blow hole" one last time – again - before it is closed by the Santa Fe National Forest as part of the FINAL Travel Management Plan for that area. The "blow hole" is a natural lava tube vent that is perched upon a hill and is some 200' deep (by estimates only) and approximately 20' in diameter.



After running this trail in October, I had requests to run it again as the "Map" for the SFNF had not been issued which means it is officially open until that map is out for public use. I had several people that had never been on the run and they were impressed. This time though, it had snowed in the area a day or so prior to us running the trail, which made it a whole new trail! Jennifer Jacobs was the only one who had been there in October, but this time she brought along her daughter, Mariah, who rarely has a day off on

weekends and this was a chance for Mom and daughter to have some fun. And that they did! We heard them laughing several times loud enough to be heard outside their vehicle. I'm glad they could have a good time as that is what it is all about. Also along were Cliff & Jeanne Meier, Erwin & Jeannie Grevin, Dixon Patrick, Jennifer Chapin, Gregg Rudtke and friend, and guest Scott Cridge. The vehicles were varied, but all made it...eventually. I brought along the Grand Cherokee this time as the Comanche is broke down awaiting some parts that appear to be "no longer available". When you're first in line in the snow, the trip is fun. If you are next in line, you are in packed snow/ice. Each successive vehicle had a harder time due to the packed snow.

I brought along the GPS coordinates from our website this time, but never needed them as I found every turn and sailed through the trail without a missed turn. That was lucky! In the "gulch" (great Colorado term!) it was even more fun than last time as the snow made the rocks and trees harder to manipulate. There is a very steep hill just after the "hole" that has lots of drop offs and deep holes to drive through. I knew when I went through there it was going to be fun for the rest of the group. It took about 20 minutes to get everyone off the hill, but they all made it and on we went. There was another hill I had forgotten about that was long and steep! 


## Christmas Tree Run By Jennifer Chapin

# Green Canyon / Cabin Trail Exploratory By Jack Dickey Photos by Jack and Cathy Dickey

I had always wondered where dirt roads in the hills east of I-25 at Arrey led. When I learned that my friend Curtis Hill of T or C and the Las Cruces Four Wheel Drive Club had been wheeling and developing trails in Green Canyon, I thought what a good opportunity it would be to do a club trip to learn the area. With a few phone calls to Curtis, I was able to set the date for Curtis to guide an exploratory trip to Green Canyon and Cabin Trail for members of New Mexico Four Wheelers.

Jeff and Paula Boggs and Cathy and I booked rooms at Firewater Lodge in the historic Hot Springs District of T or C for Friday night; while Bob and Sandy Powell made arrangements to meet us Saturday morning. Jeff and Paula made a quick get away from Rio Rancho on Friday afternoon. Cathy and I met in Socorro after work and on our way to T or C had green chile cheeseburgers at the Buckhorn in San Antonio. Both couples arrived at the motel within a few minutes of each other. After a couple of beers and some wine, we turned in early anticipating a long Saturday.

After a restful night for Jeff, Paula, Cathy and I, we meet Curtis, Bob and Sandy at the Shell station at the south end of Broadway in Williamsburg at 8:00 am. Bob and Sandy were a little weary after a 4:30 am departure from Rio Ranch, but excited to be able explore a new area. Curtis let us in on a pleasant surprise: the group was being joined by three other rigs and Harry Wagner, a feature editor for Peterson's 4Wheel and Off-Road. Curtis proposed that all of us would wheel Green Canyon to where the Bone Trail (an extreme) takes off. Cutis, his rock-buggy (a highly modified CJ on 44's with a Corvette 350 and a custom NV4500 trans), and the three other rigs, all rock buggies, would run Bone Trail then rejoin the group to run Cabin Trail. There is easy access above Bone Trail via an old two-track mining road where the non-extreme folks could watch the buggies get stupid crazy. All of us in the original group agreed to the new plan – any wheeling is good wheeling particularly when a magazine editor is there doing a story/photo shoot!

We loaded up and headed to Curtis' mom's property east of Arrey between I-25 and the Rio Grande. After a short wait, the buggies arrived: Jeff Jacobson from Albuquerque (Jeep Scrambler with a LT1 on Dana 60s), Josh Simmons from Las Cruces (YJ with a 383 stroker and Rockwell axles with rear steer), and Pete from Las Cruces (highly modified Jeep). We had a quick driver's meeting, aireddown, then headed south on the original Model-T road between Las Cruces and T or C. A short drive later, we ducked through a tunnel under I-25 and traveled east to Green Canyon. Unfortunately, Pete's jeep starting having fuel delivery issues and would be delayed in reaching Green Canyon. But, Pete knew the way and was in a good spot should he not be able to get is rig going again, so the group traveled on.

The hills around Green Canyon have a long history of mining and ranching. Area mines and prospects are part of the old Derry District where barite, fluorite, and galena were once extracted. Many of the canyons and ridges have roads and two tracks that were bulldozed for mining operations. Most of the lands are administered by Las Cruces BLM with a few sections being State Trust lands.

The trail along Green Canyon crosses sections of wide sandy wash and narrow limestone outcrops and cliffs. The first obstacle involved getting through an off-camber squeeze against a rock wall. The buggies got through encountering no concerns. I got Poco Loco through with an inch to spare using careful spotting, patient driving, and high-side counter balance. Bob and Jeff inched their jeeps through, but both suffered minor tears on passenger rear corners of their soft-tops.









The next obstacle consisted of three different notches through a rocky section in the canyon bottom. One could chose a moderate high notch, middle extreme, or lower stupid notch. Cutis took his buggy through the middle notch. Jeff Boggs, Bob, and Jeff Jacobson, and I choose the high notch.

With consistent driving and solid spotting Pete got his red jeep through the lower notch; while Josh more or less bashed his way through.









Once through, the group continued up canyon. Curtis pointed out where we would turn north for Cabin Trail near a cave/tunnel in the rock wall above us to the south. Soon we turned off the main canyon and crawled up a side canyon to Bone Trail. Pete was again having fuel issues with his red jeep and stayed in the main canyon to try to repair the problem. Without delay, the buggies slowly crawled out of sight over refrigerator sized boulders in the bottom of the wash that is Bone Trail. Us mere mortals turned around and crawled back to Green Canyon en-route to an overlook via two-

track to watch the buggies. After a slight detour while finding the two-track, we were high above the canyon and found easy walking access to a steep, under-cut waterfall the buggies faced.

The buggies not only encountered extreme terrain, but Curtis had a flat and Jeff Jacobson's Scrambler broke the passenger front main leaf. Curtis was able to get his tire re-seated and aired up. With a wrench, two vice-grip pliers, a ratchet strap, and LOTS of duct tape, Jeff J. did a field repair. On different past trips, each driver had been able to get their buggies up the waterfall. But that was not the case today. Despite expert driving and capable rigs, each had to winch over. The three rigs made it out of the Bone without further incident.





While the buggies were getting crazy and we were having a blast watching, Pete was able to get is jeep running again. He decided to check the fuel pick up in the tank. He found that the fuel line had separated from a T between two pick-up filters. When the motor was running and pulling fuel, the fuel line would get stuck to the side of the tank. But, when standing and idling, it would hang free and provide enough fuel. Problem solved!

By this time shadows were getting long. Considering the minor problems, the lowering sun, and that we all had a great day so far, we all decided to forego Cabin Trail. We returned to Curtis' property via a southern route out to Green Canyon Dam, under I-25, and back to the dusty old Model T road. We loaded up the rigs, basked in the glow that only a great day wheeling can give, thanked Curtis for is guidance, and said our goodbyes.

Bob and Sandy returned to Rio Rancho Saturday evening. Jeff, Paul, Cathy and I stayed in T or C Saturday night for a wonderful meal at the Bella Luca Restaurant and hot spring mineral bath soaking in our in-room tubs!

The trails in Green Canyon offer some great wheeling. Additional trails are being scouted for even more opportunities. Judging from the smiles on everyone's faces, I would guess that NM4W will be back.



## Chrysler Addresses the "Jeep Death Wobble" By Phil Rodacy

Chrysler has taken steps to kill the so-called "Jeep Death Wobble."

After several hundred complaints were filed with the National Highway Traffic Safety Administration (NHTSA) by Jeep Wrangler owners who experienced a severe vibration in their 2005-2010 model year vehicles, two members of Congress from California urged the company to address the issue, which it has now done by issuing a technical service bulletin (TSB, Technical Service Bulletin 19-002-12) that recognizes the problem and suggests several ways to fix it.

A probe by NHTSA earlier this year concluded that the condition "does not result in loss of control," and did not lead to a recall or other action by the agency.

The TSB maintains that the problem, a vibration in the steering system transmitted through the steering wheel, is not unique to Jeep products and is possible in any vehicle equipped with a solid front axle. It offers several causes for the issue, including the installation of aftermarket equipment, incorrect air pressure and worn steering and suspension components.

Democratic California Representatives Henry Waxman and Anna Eshoo, who in July sent a letter to Chrysler CEO Sergio Marchionne asking him to reach out to consumers on the issue, welcomed the decision with a joint statement that read, in part, "Chrysler's decision to issue an official method of repair for this problem is the right thing to do for its customers and for the safety of others on the road."

The following notice was sent to Chrysler Dealers:



#### **Steering System Maintenance:**

It is important that the steering system be kept in good working condition. Having your vehicle inspected regularly to ensure it meets proper factory specifications, and promptly repairing the steering system when it is out of factory specifications, helps ensure the vehicle maintains its intended ride, handling and steering characteristics.

Vehicles equipped with a solid front axle may exhibit steering system vibration if the steering system is damaged or not properly maintained. This condition is not unique to Chrysler Group vehicles; any manufacturer's vehicle equipped with a solid front axle has the potential to exhibit steering system vibration.

To ensure that Chrysler Group customers have the most relevant information to enhance their vehicle enjoyment -- and that customers receive the best service from repair facilities diagnosing and addressing steering system vibration -- the Company has issued Technical Service Bulletin 19-002-12 to assist dealers and repair facilities in the diagnosis and repair of this condition.

The following is a summary of the steering and suspension system elements that can potentially contribute to steering system vibration. Chrysler recommends having your authorized Chrysler dealer inspect these elements should you experience steering system vibration:

- Is the vehicle equipped with aftermarket components or other modifications (e.g. lift kits, wheels, suspension components or tires) that can affect the performance of or wear upon steering components?\*
- Check the air pressure in the tires and ensure they are inflated to the recommended pressure. This value can be found on the tire placard located on the driver's front door enclosure.
- Inspect the tires for signs of unusual or uneven wear, cupping or other damage.
- Ensure that the tires/wheels are balanced within specification
- Inspect the steering damper for excessive wear or damage.\*\*
- Inspect the track bar for excessive wear or damage.\*\*
- Inspect the tie rods for excessive wear or damage.\*\*
- Inspect the drag link for excessive wear or damage.\*\*
- Inspect the ball joints for excessive wear or damage.\*\*

If you have questions regarding your vehicle, its ride and handling or steering characteristics as they may relate to steering system vibration, please consult with your authorized Chrysler Group dealer to have your vehicle inspected.

<sup>\*</sup> Installation of aftermarket steering and suspension components or wheel and tire assemblies that are either not compatible with your vehicle or not designed for on-road use is most often the cause of steering system vibration, in which case you may consult your aftermarket equipment manufacturer or vehicle modifier for repair suggestions.

<sup>\*\*</sup> If any of the steering or suspension components are replaced, a front end wheel alignment is required.



# **Penetrating Oils**Contributed by Laurie Rector

Machinist's Workshop Mag<sup>TM</sup> recently published some information on various penetrating oils that I found very interesting. Some of you might appreciate this. The magazine reports they tested penetrates for break out torque on rusted nuts.

They are below, as forwarded by an ex-student and professional machinist. They arranged a subjective test of all the popular penetrates with the control being the torque required to remove the nut from a "scientifically rusted" environment.

Penetrating oil	Average torque
None	516 pounds
WD-40	238 pounds
PB Blaster	214 pounds
Liquid Wrench	127 pounds
Kano Kroil	106 pounds
ATF*-Acetone mix	53 pounds

<sup>\*</sup>ATF=Automatic Transmission Fluid

The ATF-Acetone mix was a "home brew" mix of 50 - 50 automatic transmission fluid and acetone. Note the "home brew" was better than any commercial product in this one particular test.

Note also that "Liquid Wrench" is almost as good as "Kroil" for about 20% of the price.

Steve from Godwin-Singer says that ATF-Acetone mix is the best and you can also use ATF-lacquer thinner 50 - 50 mix.

(Editor's note: Be cautious when using acetone or lacquer thinner around painted surfaces as they can soften or remove many types of paints. Likewise, they often attack rubber and other polymers, causing them to swell or degrade.)

### President's Report By Dixon Patrick

Well here we are and its February already. I know we normally have at least one ride a month, but not much has gone on. I even looked at the president's report for this time last year, and nothing. ## **Director of Environmental Affairs By Frank Whiston**

A couple weeks ago, Mark Werkmeister and I attended a meeting at the Socorro BLM office regarding the travel management plan for Gordy's Hill (which the BLM now wants to call Johnson Hill). In order to bring things into prospective since things progress so slowly within the government, I'll begin with a little history.

In the 2004-2006 timeframe, Mark worked diligently with the BLM to establish a trail system in the Gordy's Hill area. Mark mapped the whole area with BLM equipment, and "pioneered" some of the best routes by himself and the 'Rat Pack', a group of hardcore rock crawlers from around the country. As the BLM got closer to the Resource Management Plan being completed, Mike Bilbo (BLM Rec at the time) asked us to hold off on putting new tracks down on the rest of the proposed trails until after the RMP was officially approved. Unfortunately for us, Mike left the office prior to the RMP being completed. So......many of the trails have never had tracks on them since we were waiting for them to be officially designated.

Fast forward about 4 years. July 28, 2010 Danita Burns, the Field Manager for the BLM Socorro Field Office released the approved Resource Management Plan (RMP) which provides guidance for managing approximately 1.5 million surface acres and 6 million acres of Federal mineral estate in Socorro and Catron Counties. The RMP Designated Gordy's Hill as a Special Resource Management Area (7,647 acres) for recreation uses, including OHV, races, and group events. The RMP also states that "Preliminary travel management plan networks will be developed for areas outside of WSAs within 5 years of the Record of Decision for this RMP (contingent upon available funding and staff resources). Priority areas for completing these travel management plans are as follows: (1) Gordy's Hill, (2) ACECs, (3) SRMAs, (4) SMAs, and (5) all other BLM-managed land."

That brings us to the present. A lot of time has passed and the public has been out using the routes and trails that were pioneered by our own Mark Werkmeister for up to 9 years now. The BLM has done surveys by various methods including studying aerial photos to see how the present condition compares to the route data that Mark provided years ago. Guess what; there are discrepancies! Mark didn't bother with mapping the many miles of sandy whoops that the motorcycles and ATV's had made, especially in the north part of the area. That explains much of the "discrepancy" between the 2004-05 mapping and the current trails. So, what does this mean?

The BLM must go through another NEPA process to perform the task underlined above. The good news is that the BLM has engaged the off-road community for help before NEPA. The BLM is asking us to re-trace all of the routes that have been driven and help the BLM classify them by vehicle type and difficulty level, using their GPS equipment. The bad news is that they do not want to include any of the not previously driven, proposed trails that we were asked to not drive on years ago.

The bottom line is that the BLM has invited us to be an active participant in this process. To date, I am not aware of a better opportunity for the off-road community to have a positive impact on the Travel Management process in the state of New Mexico until now. The question is, what will you make of it? Will the club stand up and get involved, or will the membership be apathetic and allow the BLM to make uninformed decisions that will affect the future of motorized recreation at Gordy's Hill?

The Legal Notice for the 2<sup>nd</sup> 30-day comment period on the Camino Real EA was published Jan 24<sup>th</sup>issue of the Taos News. Based on that publication date, the deadline for comments is midnight, Feb 25<sup>th</sup>.

A legal notice for comment was published in The Taos News on December 13, 2012. The Forest Service has decided to provide a second comment period that ends 30 days following the date of publication of this legal notice in The Taos News. This publication date is the exclusive means for calculating the time to submit comments on the proposed action. Those wishing to comment on this proposal should not rely upon dates or timeframes provided by any other source. Only those who provide comments or otherwise express interest in the proposed action during the comment period will be eligible to appeal the decision. Interest expressed or comments provided on this project prior to or after the close of this comment period will not constitute standing for appeal purposes. Comments must meet the requirements of 36 CFR 215.6. Those who provided written or email comments during the first comment period need not resubmit their previous comments.

Comments are to be submitted to Forest Supervisor, 208 Cruz Alta Road, Taos, NM 87571 (FAX: 575-758-6213). The submission of comments must include a name and address of the commenter and the title of the proposed actions "Travel Management- Camino Real Ranger District". Comments may be submitted by email in MS-Word (.doc or .docx), rich text format (.rtf), text (.txt), Abode (.pdf), or hypertext markup language (.html) to: commentssouthwesterncarson@ fs.fed.us. "Travel Management- Camino Real Ranger District" must be in the subject line of the email. Comments may also be hand delivered weekdays 8:00 am-4:30 pm at the above stated address. To be eligible for appeal, each individual or representative from each organization submitting comments must either sign the comments or verify identity upon request. Names and addresses of commenters will become part of the public record, which is subject to release under the Freedom of Information Act (FOIA).

This year the Rockin' New Year's Eve Bash was held on December 29, 2012. This is an annual event that is in its 5<sup>th</sup> or 6<sup>th</sup> year. Oh well, who's counting anyway? We use to camp out on this weekend and have a pot luck, but realized that it can be really cold this time of year and this year was especially true.

Some participants were new to the BLM area that we call Gordy's Hill. So, Jeff Boggs volunteered to meet them at the Phillips 66 at the Lemitar exit. It would be easier to do that than give directions on how to get there. I thought it would be a good idea if I were there too and Jeff Rector decided that he would too.

So, several of us met there at 7:30. I had said that we would leave there at 7:45 and we did. Temps were about 11-14 degrees (not sure if mine or Jennifer's were correct, but who's going to argue over 3 degrees?). I found out later that a couple of other people stopped there, but no one was there. Luckily they were familiar with Gordy's Hill and caught up with us at the staging area.

The following people were in attendance: Scott Cridge – 2013 Jeep Wrangler 2 door (brand new – had 160 miles on it), Carol Bevel & Russ Irwin – in his Toyota Tacoma, Andy Schulze & Theresa Chamas – '96 Jeep Cherokee, Jeff and Paul Boggs – '06 Jeep TJ Wrangler, Jeff Rector – 1984 Jeep CJ7, Lauri Rector – '12 Jeep Rubicon Unlimited, Mike Coe – '97 Jeep TJ Wrangler, Kristy Coe – '97 Jeep TJ Wrangler, Jack Dickey – '84 Chevy K3500 Trail Blazer

Jeff Boggs volunteered to lead the smaller tires, stock vehicles and anyone else who wanted to go with them. There were some places he wanted to explore that were more arroyos and wider places that everyone should have no problem with. Jeff Rector wanted to run Coyote Hills and "look" at Edge Canyon. Mike and Kristy wanted something more challenging and it was easy to talk Andy Schulze to come along. I knew I probably shouldn't, but just had to see if I could maneuver my Rubicon up Coyote Hills. So off we went. The rest of group was very surprised that I went off with them and had a moment of silence for my safe return.

Jeff Rector found the turn off for Coyote Hills right away. He normally has to turn around after about a 100 feet. We got off the main road and got into 4 low right away. Jeff only stopped and glanced at the 1<sup>st</sup> obstacle and took the by-pass. It looked bad, he's never made it, more obstacles ahead, so why waste any more time? The next obstacle is like a devils punch bowl with no by-pass (well, there is one, but it has a sign). Jeff went up made the turn, backed up to get the right line and went up. Andy was next and didn't do it quite that easy. I thought Kristy was going to rip her new top getting into to the punch bowl. I had serious doubts I could make it, even with a spot. Kristy finally got up and out after taking the hook. Jeff spotted me into it. I got 2 tries and a lot of rocks and had to take the hook, which didn't work until Jeff moved his Jeep. I got up, but it was really scary for a few seconds. This was my 1<sup>st</sup> at trying a ledge that high. Mike got up finally as well, but he too had to take the hook.



The next obstacle was another nasty little ledge too. Jeff got up again with no problem. Andy needed help. So, Kristy and I got our winch cables out and ready to go for when it was our turn. Kristy, me and Mike all 3 took the hook on this one as well.

The next ledge was even worse, but we all got up unaided. Andy took several tries. Kristy tried Andy's line and lost a flare and dented a fender before taking a spot and the suggestion of a different line. I had to let Jeff drive it up. After several tries, we found a position that I didn't hit my bumper on it (it's a stubby, it's a really short bumper!!!), but I couldn't get the rear tires to come up and over. Jeff was able to get it. Mike came up his own way and made up, with a little too much skinny peddle.

Next there was a smaller ledge after a very tight turn in the arroyo. Everyone maneuvered through this with ease, except for me. Jeff had to yell at me to back up and go straight for a little longer before turning and coming up the ledge.

A few feet after that, we get into much larger rocks with a tight turn and a tree. I'm sure Jeff made it right through and I don't think that Andy had too much trouble. But, there I was stuck right behind Kristy, bless her heart. Big tree on the right – trunk right on the edge of the trail and limbs way into the trail, left turn before you clear the tree, with a big rock on the left and one just past the turn on the right – both just big enough to cause body damage. Kristy got way up on the rock on the right and got a lot of air with her left tire – so much she was too close to vertical for my liking. I had to try about a dozen times before I made it and some spotting from Mike while he was still in his Jeep. I was doing that insanity thing where I was doing the exact same thing each time and was expecting a different result.

The next 2 obstacles are one right after the other and come right after you make it through a large boulder field. There is a big rock that is more like a slab with a tree on the right side, which most of it has been cut down. I have no idea what Jeff and Andy did going through this. Jeff has 40" tires, he makes it easily through a lot of things. Andy may have had to work on the ledge that comes right

after the big rock slab. Kristy, I got to watch. She worked her way to the right and into the tree, then she almost fell backwards. Then Jeff came to spot her and she got up it after a few more tries. Then I stood there analyzing this obstacle and the rocks before it as I listed to Kristy trying to get up the ledge. I had just enough time to realize that I had nothing more to prove that day. I was good. I had my fill of ledges and looking up at nothing but sky. So, I left Jeff drive my Rubicon up the next 2 obstacles. He went up that slab and barely spun a tire. This is what I've been seeing him do in my Rubicon and this is why I think that I can wheel it just about anywhere myself. The ledge caused him some problem, but he made it. Mike made it up with very little effort.



There is a narrow arroyo you can go up to get to the top or there is a by-pass. Jeff, Andy and Kristy started up the arroyo and Mike followed me up the bypass. Andy barely got started before he got hung up on a rock, then his Jeep died and it wouldn't start. He tried and tried to get it started and it wouldn't. So, Jeff drove back down, hooked the strap up to him and tried to pull him up to the top. It wouldn't go. So, he turned around and hooked the winch to him and that didn't work either. So, Kristy got around Andy and she hooked her winch to Jeff. That didn't work, so Kristy hooked her winch to Andy too and Jeff and Kristy finally got Andy to the

top of the hill. Andy checked fuses 1<sup>st</sup>, it's what he does when something doesn't work. It started right up. We had lunch in the warm sunshine and enjoyed the view and each other's company. Then we got back in our Jeeps to finish the trail, which was very uneventful.

Joining Jeff Rector (modified 1984 CJ7) and Lauri Rector (2012 Rubicon Unlimited), on Coyote Hills, hard/extreme trail, were Andy Schulte and Theresa Chama (modified red Cherokee), Christy Coe (Jeep TJ), and Mike Coe (Jeep TJ). Mike and Christy were down from Utah for 2 weeks and really wanted to get to Gordy's for wheeling opportunities.

After dividing up, Jeff and Paula began with an immediate left turn from the staging area, up a hill in 4low. But WAIT.... Jack Dickey's Blazer would not start!! What the.....!! It was determined that his starter was hung in the flywheel. He thought his day was over, but we tried a tow strap and a pull, since he has a clutch. POW, it started up. After starting the Blazer a few more times, Jack decided the starter would be good. Cold temps were the probable cause. No more issues the rest of our day (It was too early to say that).

I did not let on that this was a beginning of an exploratory route to see if we could follow 2 tracks south, avoid the main dirt roads and connect with the road to the Barite mines area. The name will be changed to Johnson Hill because the BLM cannot name it after someone who is alive. And even though Mark Werkmeister spent hours walking and mapping out possible trails and then drove over most of those trails, BLM is now saying that these maps are dated and they need new data. They also need for the difficulty levels to be identified for each trail and to know what can use the trail. If you have time to go down there, stop by the BLM office and get one of their tracking devices. Frank has contact info. There may be training sessions on how to use this equipment. Frank said that the BLM have some ideas that could be very good, such as a kiosk at the staging area where you scan a map into your smart phone. NMOHVA has some bills going through the house – one in senate and one in the house. On Sunday we spent some time talking with a gentleman who has a ranch in the Jemez Mountains. He fought last year's fire. He blamed the fire on the lack of logging, stopped by the radical enviro's, years ago. He said that the forest has grown thick with trees and the forest service is to blame for not keeping it healthy. He said that there were fire fighting crews on the scene within 15 minutes of the reported fire, but the intensity, even by then was huge. Already too late to enter the area.

He said the fact that the forest service did not go in the Cerro Grande fire area and clean it up, left fuel for this next fire to burn again.

The Forest Service is not fit to mange our public lands!!!! He said that yesteryear's forest rangers were much more open to the need for well managed logging of the national forests.

Closing these areas off and letting "Nature take it's course" is impossible, because these forests were logged a century ago. They are not natural anymore. They must now be tended to as one would tend a large Garden. Paths, aka roads, and trails to access all areas are needed. Cleaning up dead fall, thinning, pruning, replanting, harvesting, fire breaks, etc. are crucial All trees would receive more water, if there were less of them.

## Winter Break Project By Frank Whiston


Since there has been a lack of club runs to report on, I thought that I would share a little project that I did on the Jeep between Christmas and New Year's. So, I picked up a tool set on Black Friday to expand the tools that I carry in the Jeep. The set that I had been carrying just has 1/4 and 3/8 drive sockets, where I need to get into the 1/2 drive to get the larger sizes on the Jeep. I found out that what I was carrying to be inadequate





when my dad lost a bolt securing a lift bracket to the frame of his Jeep on Imogene Pass last summer. I had a bolt, but no wrench big enough to turn it. Here is the set that I picked up for \$99. I initially thought that the case it came in would work well in the back of the LJ,

but it is just not a good size for the constraints that I have. I carry a CO2 tank standing near the tailgate on the drivers-side of the cargo area. I also carry a ~12x20x16 cooler and a basket for dry food. I will also note that I have re-located the back seat rearward 3" to gain more room needed for 4 passengers. Plan A was to make a platform that would accept the drawers from the tool box that came with the tool set, but the size of the drawers would not work with the space that I have. I found some fiberglass pans that are the right size to make some drawers from <a href="McMaster-Carr">McMaster-Carr</a>. I ordered two of the Heavy Duty Fiberglass Pan Stackable, 23-3/8" Length X 12" Width X 3-1/8" Height as they are the perfect size to fill the floor next to the CO2 bottle. I was a little nervous ordering these essentially sight unseen as the generic picture from the website did not tell much. When the pans arrived, I was very pleased with the size and quality of them. They should work out perfectly. Now I was able to leverage my professional training to assist with visualization of what I wanted my platform to look like. So, I made a CAD 3D model of the platform that I wanted to build.



The platform was fabricated out of 1/2" thick plywood and painted with truck bed coating that is available in a spray can. The small strip under the pans will attach to the two bolts in the Jeep tub currently securing the car seat "latch" tabs. The platform will cover the entire cargo area with the exception of the cutout for the CO2 bottle. By locking the tailgate, even with the top off, my tools should be secure enough for keeping the honest people honest. The hole in the platform is to accept the CO2 bottle. The Quickfist clamp that I am using to secure the bottle has a base that will allow for the thickness of the plywood on the side of the tub. I have room for the strip along the bottom because in 2004, the carpet had a very thick mat in effort to make the interior more quiet. I believe that this was unique to 2004 and it was dropped for the more traditional thin carpet in later model years. The carpet mat

will keep the drawers fitting snug in the openings of the platform.

To secure the other end of the platform, I tied into the footman loops that are in the cargo floor. In the picture, you can see the small turnbuckles that attach to the metal strips which screw into the platform. The back seat will cover all of this. It is not ultimate



security, but it would take someone a while to get anything out of here. The main objective was out-of-the-way organization for tools and recovery equipment.



Since the bulk of the fabrication was done, I went ahead and loaded the drawers to see how things will fit. The tray on the left has the Lowes tool set as well as a few additional tools that I was already carrying. I still need to make some pouches to contain the wrenches and ensure that they are rattle-free. The right tray has my tow strap, receiver D-Ring, winch controller and additional D-rings. Everything is fitting quite well. The black material that I used is UHMW polyethylene which I picked up from the scrap pile at the

local plastic supply company. It will provide a nice slick surface for the trays to slide on.

At this point, my project was stalled for a couple of weeks, so I did not finish by New Year's as planned. It was too cold to paint it! So, a few weeks passed and it finally warmed up enough to paint. After paint, I installed a thin piece of aluminum angle to protect the back edge of the platform and installed it in the Jeep.

## Director of Environmental Affairs By Frank Whiston

Three points to talk about this month. First is the comment period for the Farmington BLM Travel Management on the Glade area ends April 5. This is impacting a world class 4WD and rock crawling area.

Next is that President Obama signed proclamations a week ago designating five national monuments. The largest monument by far is the 243,000-acre Rio Grande del Norte, a rugged river gorge and plateau in northern New Mexico that Obama described as a "stark and sweeping expanse" of canyons, volcanic cones, wild rivers and native grasslands. It will be managed by the Bureau of Land Management as part of the National Landscape Conservation System.

Environmentalists have called the area one of the most ecologically significant in the state, citing its importance to elk, bald eagles, peregrine falcons and great horned owls. This is hard to believe given that the area is predominately flat area covered in sage brush. The Rio Grande Gorge and Taos Plateau are also used extensively by hunters, rafters and hikers.

"The protection of the Río Grande del Norte will preserve its cultural, prehistoric, and historic legacy and maintain its diverse array of natural and scientific resources, ensuring that the historic and scientific values of this area remain for the benefit of all Americans," Obama said in his proclamation.

While new mining and oil and gas leasing will be prohibited, valid existing rights, including transmission rights of way, will be maintained, in addition to grazing and the traditional collection of firewood and pinion nuts for personal noncommercial use, the proclamation states. Sounds rather benign, but history shows that NM declarations have almost always lead to increased restrictions for motorized recreation.

Finally, I'd like to thank those from NM4W who attended the NMOHVA annual meeting ©. NMOHVA has had a big year, yet faces many challenges into the future.



#### Cedro Peak Run By Cliff Meier

On Saturday morning, March 23, 22 tough folks in 17 vehicles met at the Sandia Ranger Station parking lot. Forecasted cold and wind not withstanding, we were on our way to Cedro Peak! As it worked out it was a little cool and the wind held off until we finished. Take note you wind wimps who stayed home! We had 5 club member vehicles and 12 guests.

We had a couple of surprises! The first was that our Forest Service has been at work on the full size vehicle roads, they had taken a road grader and "maintained" about half the roads we are allowed to use in the Cedro area, FR 462 and parts of FR12 and 13. Now these roads are rock, ledge and rut free. In other words, you can take 2 wheel drives anything on them. It's really great to see our tax \$ at work, **not**! You might ask why did they do this? After I dry ran the run earlier in the week, I visited the Ranger Station and asked them. The employee behind the desk knew exactly what I was going to ask before I got 6 words out! She said, "It was a big mistake, the grader driver thought he was supposed maintain the road and that they would not ever do that again". So from now on runs around Cedro area will be known as Cedro Road runs! The other surprise was that our fearless trail leader started the run from the east end of FR 462, off the Bartula Baca Rd (near the Zuzak I-40 Exit) not the usual west end which is south of the Ranger Station. We all aired down and used the facilities at the trailhead.



The overall route was a sort of figure 8 with a short drive down Juan Thomas Rd at the top. We proceeded up FR 462 through a patchwork of Forest Service and private lands. We went through the area where the controlled burns have been this winter. After a short while we

intersected FR 13 and continued on the upper ridge to FR 252, right below the radio towers and fire watch station. After a short stop at the group picnic area on 252 we continued on to Juan Thomas Rd and then on back to the stair steps on FR 242.

After spending some time there we went back to the picnic area for lunch. After lunch we proceeded back to FR 13 and back tracked to the 4x4 Meadow Ridge all vehicle trail that connected with FR 12 in the lower valley. Didn't need to worry about the normal deep ruts

on 12; they have been completely graded over. We then looped back up to FR 462 and continued to the Chamisoso Trailhead beside Hwy 337 (old 66). With the exception of some CB problems, the intrepid trail leader's new professionally installed antenna squealed like a banshee! It was later figured out when a loose antenna grounds itself, it doesn't work very well! But Overall it was great day!

**DIRECTOR OF ENVIRONMENTAL AFFAIRS REPORT – Frank Whiston**: NMOHVA had their annual meeting at the end of March. Discussions on the past year and what had been accomplished and plans for the upcoming year.

Recent update on the NMOHVA lawsuit with the Santa Fe National Forest in regard to the new Travel Management Plan map that will soon be published: Several groups and organizations have filed as interveners in this lawsuit – so that the forest can settle with NMOHVA out of court. They are The Center for Biological Diversity, Wild Earth Guardians and the Sierra Club. Recently the Forest has had to provide Administrative Record (AR) index to NMOHVA for review. These are the documents used to make their decision on what trails will be open and be on the Travel Management map. There were 1200 documents provided. However, NMOHVA has requested that all (AR) documents be included and provides a list of the missing documents. After the administrative records are agreed upon, NMOHVA will give the courts their Opening Brief. Then the Santa Fe Forest will give their Response Brief. Then NMOHVA will file their Reply Brief. By August, there should be oral arguments, at the judge's discretion.

## **Congress Introduces Bill to Help Prevent Road Closures, Ensure Public Participation When Designating National Monuments**

Legislation (HR 1459) has been introduced in the U.S. Congress to require the President to complete an environmental review under the National Environmental Policy Act (NEPA) before designating more than 5,000 acres as a National Monument. The bill would ensure public involvement in the process and discussion of multiple factors including economic impact. Current law provides the President with authority to declare land of "historic or scientific interest" to be a National Monument which can lead to road closures for motorized recreation, among other activities. While this authority has only been used 137 times in 100 years, vast amounts of land have been set aside in the process. SEMA and the SEMA Action Network support a collaborative approach to land-use decisions, including input from local citizens, elected leaders and other stakeholders.

### We Urge You to Contact Your U.S. Representatives Today to Urge Their Support for H.R. 1459

- Under the law, the President can designate monuments through Executive Order without input from the local community.
- H.R. 1459 would ensure that local recreation enthusiasts are included in the decision-making process for any National Monument over 5,000 acres. The bill would require an environmental review under the National Environmental Policy Act (NEPA). Monuments of smaller sizes would not require a NEPA review, but would expire after 3 years if not ratified by Congress.
- H.R. 1459 limits the President to one monument designation per state, per four-year term. Any additional designations would be subject to approval by the U.S. Congress.
- H.R. 1459 ensures a more collaborate public approach to land use decisions and would include a discussion on the positive economic impact of motorized recreation activities, which accounts for over \$257 million in annual economic impact nationwide.

• In 1996, President Clinton set aside 1.9 million acres of land in Southern Utah as the Grand Staircase-Escalante National Monument. President Obama is now under pressure to establish a 1.4 million acres "Greater Canyonlands National Monument," closing 1,050 of off-road vehicle trails and monitoring another 1,450 miles for future closure.

#### Big Foot Ruin Run 20-APRIL-2013 By Dixon Patrick


Big Foot Ruin is an abandon Indian village in the Jemez Mountains. On Saturday 20 April, 17 vehicles hit the trail on a mildly cool but sunny morning. Because of the Travel Management plan, we can no longer cross the river and the alternate road that starts North of Porter Landing to avoid the river that was in the original plan has been removed. So with no access from the South we had to enter from the Northern end, travel south and then return the same route.

FYI: We were not able to get maps from the Forest Service to determine our location. FYI the Forest service did have available an overlay map that you can down load for a GPS or Google Earth. Thanks to Frank Whiston for this link:

http://www.fs.usda.gov/detail/santafe/landmanagement/projects/?cid=stelprdb5411664 and then click on Travel Aids, then select the map you need, it will download to your computer.

Of the 17 Vehicles, we had 10 members, 5 Guest, 1 applicant (first ride with us) and 1 from Kansas. We would have had one more, but Tracy Bakewell had Jeep issues and had to return home. After airing down, we stopped above the triangle store and looked down on some tent rocks. It is a big view with a big drop off. It is hard to describe in words what we saw, the sun, trees, relatively good roads with the occasional "go around" for real bad sections. A few sections did challenge our driving skill but all made it without incident. While on Virgin Mesa, we stopped for lunch and looked down into Virgin Canyon that is just above the town of Gilman on FR485. The Geology of the area has rock with holes large and small. This is volcanic ash that had air trapped in it when it

turned to rock. Today we can sit in many of the holes for a photo opp.



After lunch we continued to the turn off for the Ruins, but per the management plan the road is closed by law and not a sign. Everyone was in for the 1000 yard hike to the top and view the ruins. After a survey of the area, finding the outline of home sites some with the wood still in them, a Kiva and pottery shards we regrouped and continued. Continuing south we came to the end of the trail, another unmarked line in the sand. We were able to look down on FR485 just south of Porter Landing.



We reversed our tracks for the exit of a long day. At one of our turns we could have been able to go straight on a road (now Closed) to see old log cabins, from the logging days. So this was a great run and I am sure we will do it again but it seems the Forest Service deliberately closed off the access to many of the locations that make the run more interesting. This is where we need to support NMOHVA to get our trails back. This run is only an example of many we have lost.

DIRECTOR OF ENVIRONMENTAL AFFAIRS REPORT - Frank Whiston: The NMOHVA lawsuit has had some back and forth on the Administrative Record. Some things were elected to not be included by the Forest Service, so NMOVA has volunteered copies of it and it's now up to the Judge to determine if it will be included. The documents that the Forest Service elected to omit from the Administrative Records were the maps that were published prior to the Travel Management process' beginning. The Gila Forest Travel Management is expected to be out this month. The Draft on Magdalena Ranger District should be out very soon. The BLM process is still ongoing, as is the Palomas Gap and Caballo Lake process. The Las Cruces club is wanting to get training on how to write substantive comments to the Forest Service and BLM. We have several members who are working on getting them help and information on this as well as having discussion on procedures and time lines to follow. The BLM in Socorro wants help in mapping the Gordy's Hill area. They have the GPS equipment for us to use. Even though this has been done, there is due process that has to be followed and at least they are involving us early on. #### Travel Management Lemonade, A Trip to Eureka Mesa

When the SFNF released the Environmental Impact Statement (EIS) for Travel Management last fall, we were disappointed with the magnitude of road and trail closures on the forest. Then the Motor Vehicle Usage Map (MVUM) came out this spring, leaving off even more of the routes that the club has enjoyed for decades. What makes this even more frustrating is the fact that NM4W has been there during the entire SFNF Travel Management process, providing input as outlined by the law, the National Environmental Policy Act (NEPA). NM4W's Mark Werkmeister even went so far as to submit a Citizens' Alternative document which included maps and descriptions of the club's favorite routes and camping areas, why we do what we do, and the economic

impact we have on the local communities. He essentially spoon fed the information to the forest service that was needed for their EIS, but none of it was used. The SFNF aligned with groups such as the Center for Biological Diversity and Wild Earth Guardians instead, writing the EIS to meet their agenda.



About a year and a half ago, Mark Werkmeister forwarded a video to me of some UTVs at a mine that was said to be in the Jemez Mountains asking if I knew where this was. I viewed the video, recognizing some of the surrounding landscape. Then I took to Google Earth on the computer and pinpointed the location to be just north of the



Deer Lake community, along the Eureka Mesa. This spot looked really neat, but it was too late in the season to go and check it out. We have a big lemon here, so I decided to make some lemonade after studying the routes that we are allowed on, which are displayed on the MVUM. The roads leading to this mine were on the MVUM, so a trip to check it out was in order. Even though NMOHVA has filed a lawsuit to reverse the travel management decision, as law abiding citizens, we must abide by these severe access restrictions.



Eight Jeeps and two Early Broncos gathered in San Yisidro on Mother's Day 2013 to experience what would be a nearly perfect day in the mountains. After about 30 minutes of driving north on



Highway 550, the group turned toward the mountains via County Road 11/Old Highway 44. Once in the forest, we traveled on FR 20 and 533 to work our way north to NM Highway 126. Recent rains calmed the dust to a point such that it was almost non-existent. The next turn was on FR 70, toward San Gregorio Reservoir. Just short of the trailhead to the lake, we turned west, traversing a somewhat technical descent off the top of Eureka Mesa. We arrived at the abandoned Eureka Copper Mine just in time for lunch.

Natives of the area say that copper was first mined and smelted by the Conquistadores, who used Indian slaves to extract ore and coal locally. The arrival of the Santa Fe Railroad revolutionized the mining industry in New Mexico. Now base-metal ores and coal could be carried cheaply to smelters and other markets, and low-grade precious metal deposits could be worked at a profit. The Eureka Mine was a part of the Nacimiento mining district. Between 1881 and 1960 the district produced about 7,500,000 pounds of copper and several tens of



thousands of ounces of silver, valued at over \$1,100,000. Hand-sorted high-grade ore was hauled by wagon to a 30-ton smelter at Copper City (now known as the Deer Lake community), and matte was hauled by wagon 60 miles to the railroad at Bernalillo. However, like most mining enterprises during this period, Eureka was able to operate only in times of high metal prices. Not a single metal mine in the area was able to operate continuously for the 10 to 15 years ordinarily considered the minimum period for a profitable undertaking. Since 1900 there have been two short-lived attempts to revive the district, the first from 1916 to 1920, the second from 1955 to 1957. The dollar value of production in 1956, \$231,831, was probably the highest in the history of the district. Most of it can be credited to the Eureka mine in Rio Arriba County. Analyses of mineralized fossil wood from the Eureka, Nacimiento, and San Miguel mines show that copper ranges from 38.9% to 65.8% and silver ranges from 5.6 to 6.8 ounces per ton. Mineralized fossil wood constitutes a small percentage of total rock volume at these localities; however, it contributes significantly to the average grade of ore in these deposits. Samples of rocks show a maximum of 4.7% copper and 0.088 ounce of silver per ton. The Eureka Mine could probably yield several tens of thousands of tons of lowgrade ore today. The high cost of transportation remains a severe handicap.

After some lunch, checking out the mine tunnels, and enjoying the view of Cabezon to the west; the group backtracked to FR 70 and continued on to the east. With an appetite for rougher terrain, we chose to travel FR 329 which comes within less than 1 tenth of a mile from the border of the San Pedro Parks Wilderness. Surprisingly, the open meadows were lush and green with small patches of snow remaining in the spots in the trees most protected from sun. I sure am glad that I had the MVUM loaded onto my GPS along this road as there are several other roads leading of this one that are now illegal to travel. FR329 eventually joined back up with FR 70, on which we continued on until reaching FR 103. At this point, the rest of the way back would be rather smooth and/or gravel, so those who had aired down filled their tires back up. We still did not experience any significant dust until on Highway 126 toward Fenton Lake.

I must say that there is nothing like a trip such as this one to remind ourselves of why we continue to fight for maintaining motorized access in this forest. <a href="MOHVA"><u>NMOHVA</u></a> is the only group fighting this decision and they need your support. Ask yourself how much your experiences in the Jemez are worth and donate to the Access Defense fund.



Santa Fe National Forest Lawsuit Update: Initial argument has been made by NMOHVA (which NM4W supports) to the Court. Next, the Forest Service makes their argument. Then NMOHVA counter argues. The Judge has denied Intervener status to the environmentalist's side. Although this is a rather minor decision, the other side is appealing and using up funds to do so. Without an Intervener, the Judge has to make a decision. Frank noted that rumor has it the Gila National Forest's lawyers are reassessing their Travel Management Plan before releasing it. They've taken note of the SFNF lawsuit. It's a continual battle but Frank is hopeful that our voice is being heard. The lawsuit is costly and NMOHVA can always use more capital. At today's meeting, Mark Wolf donated \$250 and challenged other NM4Wers to make a donation—every \$10 helps.

Dixon noted that the SFNF road maps are appalling. He doesn't think the general public is aware of the camping restrictions. Roads physically still exist but there are no Road Closed signs and people may get fined. Things could get ugly.

### **Smart Phone Apps for Colorado Forests**

While at All-4-Fun, the Colorado Stay the Trail organization was handing out information on MVUMs that are available for tablets and smart phones. Below is the info that they were providing.

"Stay the Trail Colorado provides a central webpage where the public, organizations and agencies can download all US Forest Service Motor Vehicle Use Maps (MVUM) for National Forests and Grasslands located in Colorado. These maps are kept up to date as the US Forest Service updates their maps. Funding for this effort is provided by Colorado Parks and Wildlife in the form of grant funding that comes from registration of OHVs in Colorado. Stay the Trail and Great Outdoors Consultants have made the MVUMs "smarter" by making sure they all have geospatial information (the map knows where it is located in the world) and by providing them multiple formats. Smart MVUMs are provided in the following formats.

#### **Geospatial PDF Files**

Some National Forests are publishing PDF versions of MUVMs that are already geospatial which means that you can see map coordinates in Acrobat Reader using the geospatial location tool (found in the analysis toolbar/menu). These maps can also be imported into some mapping programs such as Global Mapper. MVUMs that did not have geospatial information were processed to add geospatial using Global Mapper software. All PDF MVUMs were exported in the following coordinate system: UTM - Zone 13 North – NAD1983 – meters.

#### **PDF Maps** <a href="http://www.avenza.com/pdf-maps">http://www.avenza.com/pdf-maps</a>

Geospatial PDFs can also be used on Apple and Android smart phones/tablets using Avenza's free application called PDF Maps. After the PDF MVUM I downloaded on the mobile device, cellar coverage is not needed to use it. This application shows the <u>current GPS location of the user on the map</u> and allows them to perform some basic GPS recording tasks! The application allows you to show the location of geotagged photos you've taken with your mobile device right on the MVUM map. PDF Maps has an online map store that allows users of the app to find MVUMs by name or their current location. This app is being used to distribute free maps for the National Park Service, USGS Topo maps, and other free maps. The store also allows for sale of commercial maps such as National Geographic maps. All MVUMs found on the Stay the Trail webpage are now also available through the Avenza map store for free!

- 1. Go to "App Store", search for "PDF Maps" and install
- 2. Open "PDF Maps", select "Store" Function from the lower bar
- 3. Select the search function in top right corner
- 4. Search or "Stay The Trail" or "MVUM" or a Ranger District. Select from the pins that appear

- 5. Use the "Free" button to download to the phone
- 6. Downloaded maps show up in the "Maps" list on the lower left
- 7. Select the appropriate map for the district's trails you will be using. Your location appears using GPS sensor.

Note: The Android version of the PDF Maps app is a beta version and is not currently linked to the Avenza map store. <apps can be loaded in the Android version by linking to the Stay the Trail webpage MVUMs, by e-mailing the PDF file or a link to it."



### Let's Hope The Moisture Keeps Coming Run San Miguel Peak 8/04/2013 By Laurie Rector

We ran this trail many times as a club. We started from our camping area near porter landing and would just go up to the peak and come back down. We went out exploring on Mother's Day this year when we couldn't get the gate open to La Ventana. We went into the Jemez from the west side on FR20. Jennifer Jacobs & Durango in her '95 YJ, Jason Lavy in his '08 JK Unlimited, Paul & Holly Mariscal in their '99 TJ, Donnie Walker in his '00 TJ, Jeff & Paula Boggs in his '06 TJ Unlimited, Thomas Wilson in his '98 Cherokee, Ben Dacckewicz in his '00 Cherokee, Gregg Radtke and Bessel the dog in his (as in Greg's) '13 Rubicon Unlimited, Jennifer Chapin in her '08 Hummer, Don Roy and Janie Shows in his '93 YJ, me in my Rubicon, Adam, Kate & Gabe Babb in a '01 Toyota 4-Runner (I think it's Kate's), and Scott Cridge in his '13 JK.



We met at the empty lot next to the Familia Denero (Spanglish for Family Dollar) and left soon after 9am. I gave warning for our turn off from 550 and I just about missed it myself.

We made our way over to the forest boundary and then went into the forest before we aired down. I didn't do too bad finding my way over there; I did have to back up, but no one had to turn around.



The trail is nice and easy on the 1<sup>st</sup> leg. The weather was beautiful and there was no dust, so I had my windows down. I immediately ran over fresh cow dung and flung dung all over the driver side of my Jeep and Paul Mariscal's Jeep. There were nice views as you get up fairly high in altitude. We made good time on this part of the trail, so I decided to stop in a meadow so everyone could get

## A History of the Southwest Four Wheel Drive Association

November 9<sup>th</sup>, 1991 marks the start of a dream. Alan Gilmore, founder and first president, envisioned an association with which his passion for four wheeling and the need for a southern voice in the fight for public land could come together and unite. Alan contacted other likeminded individuals and clubs, and laid down a mission.

- Promote interest and provide education in organized 4-wheeling and the safe and responsible use of off-highway vehicles.
- Keep members informed of the needs of vehicular recreationists, and to keep Association members informed of impending legislation and land use matters.
- Enjoy and protect all local, state, and national resources, and to assist various government agencies in the development of off-road trails and areas.
- Render aid and assistance as needed.

Adhere to the principles and practices of United Four Wheel Drive Associations, Blue
 Ribbon Coalition, and Tread Lightly! and to maintain active membership in UFWDA as an Association.

At Leasburg State Park north of Las Cruses, New Mexico, 33 rigs from 7 different clubs and nearly 80 people spanning across 2 states gathered for the first meeting of the Southwest Four Wheel Drive Association. The clubs represented were; Cliffhangers, FWD-FWD, Jeeps Exclusive, Sun Country Jeep Club, New Mexico 4-Wheelers, Catch'N Air, Tejano Fourwheelers, and 4x4 and More of Texas. First order was having a little fun; Sun Country Jeep Club from El Paso hosted the event and after a short orientation led the group into the foothills of the Dona Ana Mountains.

Once SWFWDA was off and running the next order of business was just that, business. The second meeting was held in Albuquerque, NM on February 29, 1992. Here the association

established the official publication

(4WDrive Lines), the motto, (Four Wheeling Responsibly), and discussed logos that had been submitted.







They decided on the logo that graces decals, t-shirts, and hats to this day.

With the bylaws and formal details ironed out the mission of the association was laid down and word began to spread to other clubs in the area and surrounding states.

By the end of 1992 SWFWDA had grown from the 7 original clubs to 14 member clubs and

54 individual members. More clubs in Texas and New Mexico were being contacted as well as clubs across the southwest. Attendance at quarterly meetings was booming and fun was being had by all.

Enjoying the sport was not the only thing SWFWDA was established to do. The 4W Drive Lines became an important resource for its members. Through the publication members were able to receive information on legislation that was taking place and effecting public lands. Members were able to stay informed of local, state, and federal land closures and openings, or proposals of such.



The officers of SWFWDA urged its members to take a stand and write letters to the representatives and agencies involved in public land use matters. Drive Lines makes an effort to educate all who enjoyed 4-wheeling as a sport; to get everyone to pitch in and make change happen. Nelson Mandela said; Education is the most powerful weapon which you can use to change the world. If members could do their part a change could be seen and land could be persevered for future generations.

As the years passed the rapid amount of growth which had been seen in the beginning began to plateau. In the fall quarter of 1995 officers of SWFWDA began to plead with member to do their part and spread the word about the association and the role it plays. Growth would mean a

bigger voice, more fun and more four wheeling. After a bit of a dry spell in new membership, SWFWDA seemed to start growing again and by the next year had 26 member clubs. That year new leadership came in and a critical look was taken at the purpose and goals of SWFWDA. The

association decided to write a formal plan for their future that contained goals and objectives that they would strive to achieve over the following years.

By the end of 1997 SWFWDA was 30 member clubs strong and the association had surpassed the 1000 member mark. Also in '97 SWFWDA established a Land Action Fund. This was a fund made up of donations from clubs, individuals, businesses, and events that help to finance activities aimed at keeping public lands opened for public use. It was not until 1999 that SWFWDA was able to put the fund into action. That year the Land Action Fund was used in two land

closure lawsuits against the Forest Service. SWFWDA was finally able to exercise their right to assess public land and was able to back up their rights in court.

In the year 2001, ten years after the birth of SWFWDA, history was made on the Dona Ana Mountains, the same place where the association held their very first meeting. On February 3<sup>rd</sup> & 4<sup>th</sup> 300 plus volunteers showed up to participate in the largest land clean up ever seen

in the area. The event was sponsored by
Wal-Mart, Rent X, US Rentals, Able Sign
Co, Brent Westmoreland, Shorty's
Chevron, Robertos', Southwest Disposal,
the Dona Ana Roads, Environmental,

Sheriff's Department, and the Dona Ana County Grants Commission. Other groups that participated were Agape Christian Church, NMSU Polo Club, Mountain Bike Club, and three different VICA clubs from Dona Ana Community College branch, Fort Seldon 4H club and countless individuals who had just heard about the event. Tony Liello spearheaded the event and he and the other members of the Las Cruses FWD club were very pleased with the outcome. Events like this are essential parts of what makes SWFWDA who they are. Rendering aid and assistance as needed was one of the missions laid out with the start of the association. For SWFWDA helping others is not an obligation it's a way of life.



2002 proved to be a rough year for SWFWDA beginning with the Spring Quarterly. With only two clubs being represented at the meeting the association did not have enough representation to establish a quorum-so no meeting. Poor attendance at quarterly meetings

had been a problem before but it had now become a critical issue. The association would have a hard time supporting its members effectively if the members would not do their part in participating.

In 2003 concerns continued to develop with the Robledo Canyon lawsuit, which was started in 1999. The winning of the lawsuit would have a major effect on not only SWFWDA but associations across the nation. The impact would open many doors for other suits against the BLM for un-constitutional land closures. However, it was a hard process because the BLM and Wilderness group had very deep pockets and SWFWDA was working solely on the support of its clubs and members. Despite road blocks the battle for justice continued on but resulted in a loss for the SWFWDA.

As time went on it became apparent that Off-Roading was growing in



popularity. The number of people 16 years and older participating in off-road activities at the turn of the century was around 37,600,000. By 2003 the number had risen to 49,600,000. By 2007 it was becoming one of America's fastest growing sports although the land availability for the sport continued to dwindle. Parents were beginning to realize the need of their families to participate in



wholesome outdoor activities. It gave SWFWDA an opportunity to pass on knowledge and teach the next generation to be good stewards of this land. But even with the rise in popularity SWFWDA had a hard time finding volunteers to fill roles as officers. It seemed that after losing the Robledo Mountain case members became disinterested in the efforts of the organization. But there are still those how have not lost hope. There are the committed members holding on to not only the fun of 4-wheeling

but to the principals laid down those many years ago by the founding members. Those who not only wanted to show others their passion and hobby, but wanted to preserve the land on which they so

loved. Though time has passed and people change, the purpose remains the same. Southwest Four Wheel Drive Association will live on thanks to that love and purpose. The story doesn't end here.

### Conejos October 10 · 13, 2013 By Frank Whiston

The third time is the charm! We have been inviting the club to join us for a trip to the Conejos area for many years now. The first time was back in 2005, around Labor Day. We only had the Meiers and Grevens with us then. Although there were no big expectations of seeing the aspens turning then, I had hoped that we would see the start. Two years ago, we returned doubling attendance with 4 vehicles. This was in late September and all of the aspens were still green. This year, we had 11 vehicles, beautiful tree color, and surprise SNOW!



Timing was chosen by the kid's school schedule where October 10-13 was Fall Break. All but the Holfielder family traveled up on Thursday to the Conejos River Campground. Robert Holfielder was watching the forecast and decided that the predicted wind and rain turning to snow did not sound like fun in their pop-up trailer. Guests Mathew and Leslie Wheeler had planned to tent camp, but secured one of the modest, but heated camping cabins instead. Both ended up being very wise decisions as the wind really howled through the night and we woke up to temperatures in the upper 20's.



Friday morning was beautiful and sunny. We headed out to the north right across the highway from the campground. FR101 is a good gravel road that ends up as a 4WD road as it progresses into the forest. As the road climbed on the North ridge of the Conejos canyon it was snow covered and the aspens were full of gold and orange color. I was afraid that all the leaves would have been on the ground with the strong winds the previous night. The snow caused a couple of slippery climbs, but was not a very big hindrance to travel, just

making it a little more fun. By the time we got above 10,000 ft. elevation, no vehicles had been ahead of us since the snow and it was getting deeper, making it hard to tell where the road bed was below. Then, I hit some drifted snow deep enough to contact the front differential without enough momentum to break through. After a couple more hits, I was able to get through the drift providing for some excitement for my girls. Once Mathew plowed through with his lower slung stock X-terra, everyone got through the drift with no issues. We pressed on making a loop through the Big Meadows area of the Fox Creek drainage. At the completion of this loop, we would cross the same deep snow drift on the opposite side of the fence. Knowing what happened the first time, I carried enough momentum to traverse the drift on the first try as did the majority of the group. As we backtracked on FR101, we made a stop along the edge of the Conejos canyon providing a spectacular vista of the colorful trees below.





A loop to the south was the choice for Saturday following the edge of Toltec Gorge to Osier, the midpoint stop for the Cumbres and Toltec Scenic Railroad. Given this was the first day of elk rifle season, I figured there would be fewer active hunters along the railroad route than other parts of the forest. We started out heading east on HWY 17 for a couple of miles near the end of Los Mogotes mesa where we crossed the Conejos river. A high clearance road was found to climb out of the valley which provided a broad view of the Sangre de Cristo range to the east. All the way from the freshly snow-covered Mt. Blanca down to the mountains near Taos NM could be seen. Just as we crossed the state line into New Mexico, we met up with the train tracks at Big Horn siding and wry.



This is the first spot from Antonito where the train could be turned around. From there, we paralleled the tracks back to the west headed toward Osier. Most of the big aspen groves in this area had already lost all their leaves. Before arriving at Osier for lunch, we made a stop to have a bit of a view down into the Toltec Gorge. We all hung out at Osier until the trains arrived and the kids placed some pennies on the track for the train to flatten. We backtracked a short distance on FR103 to FR107 to continue the loop. The hunters were out in force in this area and we only seemed to impede

a couple of them as they were driving in the opposite direction. We found a dry spot where we stopped for a 10-100 and to check out the frosted trees. As we worked up to the top of the 10984 ft. Pinorealosa Mountain, the snow got deeper and the amounts of tracks ahead of us were fewer. The snow bashing began! Although there was one set of tracks that had been ahead of us, they would leave the road quite often to avoid the deeper snow. Given that I had 10 vehicles following me, I tried to stick to the actual road as much as possible in effort to avoid further proliferation of off-trail tracks. The trouble with snow drifts, they can fill holes making for the appearance of a smooth, flat

route. I quickly fell victim to such a hole that completely swallowed my 35" passenger side tires. I called on the radio for assistance and at least Leon and Wolfie quickly got stuck too. Guest Devin Cannady took pleasure in rescuing Leon's Bronco from the snow with his YJ after following him all day having to look at the sticker on the Yellow Bronco's tailgate reading "I Love Jeeps, They Taste Like Chicken". Glenn Vialpando was able to get around me and provide anchor for my winch with his new 4Runner. Glenn would have to repeat this twice more in spots that I stopped short of making it through drifts. The rest of the group seemed to make it right through after I had made tracks on the road. After all of the snow bashing fun and excitement, we all were happy to rejoin the pavement on HWY 17 at Spruce Hole. Any more snow bashing would have been more work than fun. The highway drive back to the campground was beautiful with aspens in full color. What a great day!

The snow ended up being a pleasant surprise. It added just enough challenge to a normally very easy drive. The snow also revealed how alive the forest is leaving many animal tracks where no evidence is usually found. The white of the snow against evergreens and golden and orange aspens provided quite spectacular scenery. This was a truly unique experience which will most likely never

be repeated.
















